# **Cookie Policy**

Almirio's website uses cookies. There are performance and mandatory cookies that ensure the functioning and collecting statistics of the website. If you have agreed, in addition to this mandatory cookies, other cookies for marketing and analytics purposes may be placed on your computer or other device from which you enter our webpage. This Cookie Policy defines what varieties of cookies we use on our website and for what purposes.

#### What are cookies?

The browser you're on uses the cookies to send information back to the website at each subsequent visit for the website to identify the user and to recollect the user's choices (for example, login information, language preferences and other settings). This can make your next visit easier and the site more useful to you. So, what are they? Cookies are small text files created by the website, downloaded to and stored on any internet enabled device—such as your smartphone, tablet or computer—when you visit our site.

### What types of cookies do we use and for what purposes do we use them?

We use different kinds of cookies to run our website. Your browser may store the cookies described below.

Mandatory and performance cookies. These cookies are essential for the website to work and will be placed on your device once you enter the site. Most of these cookies saves what you do on the website such as setting your privacy preferences, logging in or filling in forms. These cookies help users efficiently use the website and make it personalized. These cookies recognize the user's device, so we would be able to see visiting frequency and quantity, but they do not collect any other personal information. You can block them or get alert about these cookies by setting of your browser, but some parts of the website will not work properly after blocking them. These cookies do not store any personally identifiable information and are stored on the user's device until the end of session or permanently.

Analytical cookies. These cookies collect information about how users interact with everything on the website. They then collect the information and use it for analytical purposes to recognize the interests of our users and how to make site more user friendly. If you will block these cookies, we will not be able to see when you visited our site and will not be able to monitor its performance. Third-party cookies may be used for analytical purposes. These cookies are saved on the user's device for period set by the third-party cookie provider (may be 1 day or more, even permanently).

Marketing and targeting cookies. These cookies collect information about how users interact with our website, for example, to see which sections are, most visited and which services are most used. Before agreeing to use of cookies, Almirio only collect anonymous data from Almirio website. The collected information is used for analytical purposes to understand the interests of our users and how to make the webpage more user friendly. Third-party cookies may be used for analytical purposes. These cookies are stored permanently on the user's device.

Third-party cookies. By visiting the websites of respective third parties, you can learn more about these cookies and their privacy policy. All information processed from third party cookies are managed by the respective service providers. Our website uses third party services, for example, for analytics services so we would know what is popular on our website and what is not, and then making the website more practical. At any time, you have the right to avoid data processing by third party cookies. For more information, please look at the section of this Cookie Policy.

For example, we may use Google Analytics cookies to help us find out how users interact with our website. These cookies collect information about your interaction with the website, such as length of the session, returning visits, unique visits and others.

We may also use Facebook pixels to process information about what users' actions are on our website such as visited webpage, browser data, user's Facebook ID, and others. The purpose of information processed from Facebook pixels is to display you interest-based ads when you are using Facebook as well as to measure cross-device conversions and learn about users' interactions with our webpage.

#### How to control cookies?

You get an informative statement that the website uses cookies, when visiting our website, and asks you to enable cookies that are not mandatory or performance cookies. Afterwards you can delete all cookies saved in your browser and you can select on your browser to block cookies from being saved. By clicking on "help" button in your browser, you can find instructions on how to avoid the browser from saving cookies, as well as to see what cookies are stored already and delete them, if you want to. Changes to the settings in your browser must be made for each browser that you use.

If you want to call off the saving of cookies on your device, you can erase all cookies saved in your browser and set up your browser to block cookies from being saved. When you click on the "help" button in your browser, you can find instructions on how to prevent the browser from storing cookies. However, please understand that with blocking certain cookies you may not be able to fully use all the features and services of Almirio's website. You can separately sign out from having your website activity available to Google Analytics by installing the Google Analytics opt-out browser add-on, which prevents sharing information about your website visit with Google Analytics.

Also, if you want to sign out from interest-based, behavioral advertising, you can do it by using one of the tools shown below, based on the region where you are. Please understand that this is a third party tool which will save its own cookies on your devices and Almirio does not control and is not responsible for their Privacy Policy.
